## PILOT CITY WORK PROGRAMME

**GABROVO**SEPTEMBER 2017













This document presents the work programme designed by the City of Gabrovo in the context of its participation in the Agenda 21 for culture's Pilot Cities Europe Programme. The work programme has been drafted by a group of local stakeholders, following the results of the initial self-assessment workshop and the document resulting from it, known as 'Radar 1'. Advice has been provided by Catherine Cullen, the expert designed by the Committee on Culture of United Cities and Local Governments (UCLG) and Culture Action Europe to support Izmir in the context of the programme. The Pilot Cities Europe Programme is coordinated by the Committee on Culture of UCLG and Culture Action Europe, in collaboration with the Council of European Municipalities and Regions (CEMR).

The work programme outlines briefly the actions which Gabrovo plans to implement between mid-2017 and late 2018. Based on the commitments and actions outlined in the <u>Culture 21 Actions</u> toolkit, it is particularly meant to address the strengths and weaknesses identified in the initial self-assessment. The work programme will be subject to regular monitoring by the City of Gabrovo, other local stakeholders and the external expert, and changes may be introduced if necessary. The implementation of the work programme will conclude with a final conference, which will allow the city to review and disseminate progress made, and to foresee future steps.

The results of the work programme will be presented in due course in Gabrovo's page on the Agenda 21 for culture website.
