



1 CONTEXT

OBJECTIVE

The objective of the “[International Award UCLG – MEXICO CITY – Culture 21](#)” is to recognise leading cities and personalities that have distinguished themselves through their contribution to culture as a dimension of sustainable development. The Award reaffirms the leadership of Mexico City in the relationship between culture and sustainable development and the commitment of UCLG to place culture as a fundamental dimension of sustainable cities through the Agenda 21 for culture.


CATEGORIES

1. CITY / LOCAL OR REGIONAL GOVERNMENT AWARD

The Award in this category is granted to a city, or local or regional government, whose cultural policy has contributed significantly to linking the values of culture (heritage, diversity, creativity and transmission of knowledge) with democratic governance, citizen participation and sustainable development. The award is given to the candidate local or regional government that wins a competitive call, open to UCLG members. The award recognises an original policy, programme or project that explicitly includes the principles of the Agenda 21 for culture. Candidatures must have been implemented for at least two years and have documented proof of the impact and the successes achieved. The winning city receives the amount of 50,000 Euros, to be used for its international promotion (the publication of a book, participation in forums, international visibility) and to strengthen the local implementation of the Agenda 21 for culture.

2. INDIVIDUAL AWARD

The Award in this category is granted to an internationally-renowned person who has made a fundamental contribution to the relationship between culture and sustainable development. The award is given by the Jury without an open competition process. The members of UCLG (direct or indirect) can make spontaneous nomination of a personality. The selected individuals receive 25,000 Euros.

CALENDAR

The third edition of the “International Award UCLG – MEXICO CITY – Culture 21” takes place between 2 November 2017 (launch of the call for applications) and late 2018 (Awards Ceremony in Mexico City).

The call for submissions for this third edition opened on 2 November 2017, with the publication of the Award [rules](#) and [application form](#).

The UCLG World Secretariat, UCLG sections ([UCLG Asia-Pacific](#), [UCLG Eurasia](#), [CCRE-CEMR](#), [Metropolis](#), [FLACMA](#), [UCLG-Africa](#) and [UCLG Middle East](#)) the UCLG committee on [Social Inclusion](#), [Participative Democracy](#) and [Human Rights](#), and the UCLG Peripheral Cities Forum spread the news of the Award among their members, and deserve special thanks. The Committee on Culture and the Government of Mexico City were also actively involved in the dissemination.

Several worldwide, regional and national networks in the areas of culture and local governance also spread the word about the Award among their members, including the [IFACCA](#) – International Federation of Arts Councils and Culture Agencies, [UNESCO Creative Cities Network](#), the [IFCCD](#) – International Federation of Coalitions for Cultural Diversity, [Arterial Network](#), [Culturelink](#), [Culture et Développement](#), and the [OCPA](#) – Observatory of Cultural Policies in Africa.

The call for submissions closed on 16 March 2018.

The panel of experts analysed the submissions presented in the two categories between 16 March and 6 May 2018, and held its final meeting on 7-8 May 2018 in Mexico City.




2 JURY

The Jury of the Award is made up of five prestigious international experts with impeccable trajectories in the cultural field.

- ◆ **Farida Shaheed (President of the Jury).** A sociologist and director of the Shirkat Gah Women's Resource Centre (Lahore, Pakistan), a pioneering centre on sustainable development issues with a gendered lens in Pakistan. She was the first UN Special Rapporteur on Cultural Rights (2013-2015) and the winner of the first edition of this Award.
- ◆ **Catherine Cullen.** Special Advisor on Culture and Sustainable Cities for the UCLG Committee on Culture, which she also chaired between 2012 and 2015. She was previously Deputy Mayor for Culture in Lille, France (2001-14) and is currently a member of the UNESCO Panel of Experts for the International Fund for Cultural Diversity (IFCD).
- ◆ **Lucina Jiménez López.** She holds a PhD in Anthropological Sciences and is the Director of ConArte, an organisation that fosters education for arts and peace in public schools and in communities. She is also one of the experts of the UCLG Committee on Culture and a member of the UNESCO Group of Experts on the Governance of Culture and Development.
- ◆ **Eduardo Nivón Bolán.** He holds a PhD in Anthropology (UNAM) and works as a lecturer-researcher in the Anthropology Department of the Metropolitan Autonomous University – Iztapalapa since 1981. He also chairs C2 Cultura y Ciudadanía, a platform for cultural policy research and design.
- ◆ **Eduardo Vázquez Martín.** A poet, artistic promoter, publisher and journalist. The founder of the journals Milenio, Viceversa and Laberinto Urbano, in 1998 he was also one of the founders of Mexico City's cultural policies. He is currently the Councillor for Culture of Mexico City and co-president of the UCLG Committee on Culture.



4 RESULTS

CITY / LOCAL OR REGIONAL GOVERNMENT AWARD

The Jury was impressed by the high quality of the submissions received and heartily undertook its difficult task. The members of the panel sincerely thanked all the candidate cities for their efforts and dedication of time, resources and hope to submit a candidacy.

The Jury evaluated each one of the 99 projects presented and provided personalised comments in the last section of this report (see chapter 6).

The Jury evaluated the ability of each project to link cultural values (heritage, diversity, creativity and knowledge) with democratic governance, citizen participation and sustainable development of cities. The panel used the following criteria in the analysis of each project:


- ◆ Complete explanation of the context: the city/territory where the project has been developed and its cultural policies.
- ◆ Concurrence of the project with the principles and recommendations of Agenda 21 for culture.
- ◆ Quality of the explanation of the general aim, the specific aims, obstacles encountered and the results obtained.
- ◆ Concurrence of the project with partner organisations, with other associated governments and with the beneficiary population.
- ◆ Analysis of the direct and transversal impacts of the project, as well as the evaluation model used.
- ◆ Continuity of the project.
- ◆ Potential for the project to be adapted or replicated in other cities.
- ◆ Use of the Award: Analysis of the pertinence of the planned actions and viability of the corresponding budget.



The Jury has decided that the winners of the Award (in alphabetical order) are the candidatures “**The Sustainable City of Lyon: The Charter of Cultural Cooperation**”, presented by the city of **Lyon** (France) and “**Common Seongbuk Artist Roundtable: Local Culture Governance**”, presented by **Seongbuk** (Seoul, Republic of Korea). Each candidate will receive EUR 25,000.

Lyon. “**The Charter of Cultural Cooperation**” has been implemented for over 15 years in Lyon, involving 27 municipal services, cultural projects and events, including those that receive the most funding from the city, which altogether carry out over 300 projects, actions and services adapted to the challenges of policies that connect culture and sustainable development across the city. Now in its fourth edition, Lyon’s Charter of Cultural Cooperation now extends throughout the entire metropolis of Lyon, including 24 municipalities. The programme has become a powerful tool for cultural policy. The Charter promotes the convergence of cultural policies, in specific commitments, with each of the transversal local policies that contribute to ‘making’ a sustainable city: urban balance and solidarity, citizen participation, policies for equality and non-discrimination, memories and diversities, education and knowledge exchange, energy efficiency, environmental responsibility and social innovation. Furthermore, the programme involves a continuous process of shared reflection, information exchange, capacity-building, project design and evaluation with all stakeholders involved, at different territorial levels and on a range of regularly-evolving themes.

Seongbuk. The programme “**Common Seongbuk Artist Roundtable: Local Culture Governance**” began in 2014 in Seongbuk, a district of Seoul, and has become the most important community initiative in this area, involving over 300 people working together on the basis of cultural governance. The Artist Roundtable defines itself as a network that works together for the coexistence and cooperation of the local culture. One of its objectives is the cooperative work with those responsible for the cultural policy of the city, through the Seongbuk Cultural Foundation and with the other public institutions with responsibility in the city. The Artist Roundtable operates on the values and principles of ‘autonomous activity’ (autonomy), ‘cultural democracy’ (democracy), ‘friendship and cooperation’ (solidarity) and ‘respecting cultural differences’ (diversity). Furthermore, the initiative organises local festivals, manages cultural venues and contributes to supporting the artistic and cultural community in the area.

The Jury also decided to make special mention of the following projects (in alphabetical order):

- ◆ **Dublin** (Ireland), for the programme “**Culture Connects**”, established in 2015. This initiative is based on people’s stories, wishes and experiences. This is a very solid, innovative programme that contributes to cultural empowerment and which has shown the importance of listening, learning and sharing with local inhabitants. It also proves that, where willingness exists, cultural policies can be useful to those who most need them.
- ◆ **Hamilton** (Ontario, Canada), for the programme “**Love Your City': Transforming Hamilton through Culture**”, based on the consideration of culture as the fourth pillar of sustainable development. The programme has taken the form of a Cultural Plan, with a holistic and integrative approach to planning, which involves the community using a variety of engagement techniques, resulting in a ‘shared responsibility for culture’.
- ◆ **Montevideo** (Uruguay), for the programme “**Cultural Policies with a Perspective on Gender Equality**”, which has been shaped after in-depth discussions with the cultural actors in receipt of public funding and has led to very specific programmes and projects in the field. Its impact proves that, where political will and operational rigour exist, mainstreaming a gender perspective in cultural policy contributes to broadening freedoms for everyone.
- ◆ **Nablus** (Palestine), for the programme “**Saving Cultural Identity under Occupation – Regeneration of Nablus Historic Centre**”, due to the commitment of local educational, civil and municipal institutions towards the regeneration of the historic centre, in order to enable local inhabitants to remain in their homes and ensure the rebuilding of hundreds of heritage buildings and houses.
- ◆ **Novosibirsk** (Russian Federation), for the project “**Novosibirsk: Turning the City into a Museum**”, which promotes cultural and artistic activities in the city’s public spaces, the uses of information technologies and citizen involvement in specific activities.
- ◆ **Saha-gu** (Busan, Republic of Korea), for the project “**Gamcheon Culture Village Project**”, a multiannual urban regeneration initiative through the arts and culture, which has contributed to revitalising the Gamcheon village. The project has involved close cooperation among residents, artists and the local government, in an innovative system of democratic governance.


These six projects are excellent examples of local implementation of the Agenda 21 for culture.

INDIVIDUAL AWARD

The Jury has decided that the Individual category of the Award be shared ex-aequo by two people (in alphabetical order):

Basma El Husseiny. Cultural manager and activist. Basma El Husseiny is now leading the organisation [Action for Hope](#), based in Beirut, that seeks to provide cultural relief and cultural development programmes to communities in crisis, with a focus on refugees and impoverished communities. She has been involved in supporting independent cultural projects and organizations in the Arab region for the past 30 years. Basma was the Arts Manager of the British Council in Egypt (1988-1998) and the Media, Arts & Culture Program Officer for the Ford Foundation in the Middle East and North Africa (1999-2003). In 2004 she founded [Cultural Resource – Al Mawred Al Thagafy](#), the Arab region's leading independent cultural organization, and was its director until September 2014. In 2006 she also co-founded the Arab Fund for Arts & Culture (AFAC), and was a founding trustee until 2009. She also co-designed the Master's Degree in Cultural Policy and Cultural Management at the Hassan II University in Morocco. Basma is a UNESCO expert in cultural governance, member of the Arab Cultural Policy Group, previous member of the Advisory Board of the [Center for Cultural Policy and Management](#), at the Bilgi University in Istanbul and the Egypt representative of the [Arterial Network](#) (Africa's largest cultural network).

Patrice Meyer-Bisch. He holds a PhD in Philosophy from the University of Fribourg, Switzerland, and completed a professorial thesis on Political Ethics at the University of Strasbourg, France. Until 2016, he coordinated the [Interdisciplinary Institute of Ethics and Human Rights](#) (IIEDH) at the University of Fribourg, and he currently chairs the [Observatory on Diversity and Cultural Rights](#) (an IIEDH programme established in 2004) and the UNESCO Chair in Human Rights and Democracy, at the same university. He is well-known for his work in the field of cultural rights at an international scale, as the main promoter of the [Fribourg Declaration on Cultural Rights](#) (2007), the result of 20 years of work by an international group of experts, known as 'the Fribourg Group', which fosters cultural rights within the human rights system. Patrice Meyer-Bisch has conducted research in several European and African countries. He has significantly influenced the understanding of cultural diversity and cultural rights as ways to achieve inclusive sustainable development for everyone and in all areas, through the effective implementation of the interdependency of human rights. In the context of these activities, cultural rights are understood, alongside economic rights as well as civil, political and social rights, as the basis, the 'grammar', the space for interpretation, for the development of all individuals and societies.

6 COMMENTS ON THE CITY, LOCAL OR REGIONAL GOVERN- MENT AWARD

Considering the high quality of submissions received and testifying the need to identify and spread the word about good practices in culture and sustainable development, the Jury would like to evaluate the projects received under the ‘City’ category with the following comments. In several cases, the Jury suggests that policies, programmes and projects submitted under this category be integrated in the ‘good practice’ database of the Agenda 21 for culture.

ABITIBI-TÉMISCAMINGUE


The project “Culturat” started in 2009 with the aim to foster social, economic, and cultural development by encouraging every citizen living in the region of Abitibi-Témiscamingue (Québec, Canada) to redefine the territory through arts and culture. Since 2012, over 450 projects based on diversity, inclusion, education and creativity, among others, have been carried out. The Jury highlights the effort of the 60 municipalities, five chambers of commerce, and five school boards in the region and other civil society stakeholders to commit together to place culture at the centre of the policies of the region, fully aligned with the values of Agenda 21 for culture. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

ANKARA

The project presented by Ankara, “Municipal Vocational Courses (BELMEK)”, is aimed to women in order to “learn how to work by plan, make friends and increase their self-confidence”. BELMEK started in 1994 and currently there are 440 instructors teaching courses related to 31 different fields of handicraft. The Jury emphasizes the willingness to address the women’s disadvantageous position in the country through this social programme and also advises the UCLG Committee on Culture to raise local awareness on the toolkit “Culture 21 Actions”.

BAĞCILAR

“The Knowledge Houses Project” in Bağcılar has gained popularity since its beginning in 2008, and today 16 houses and 64 different clubs have benefitted over 40.000 students by providing educational and social programmes to children aged 7-14. The Jury wants to highlight the commendable aim of the project to promote the right to education and the values of democracy and governance and encourages Bağcılar to continue ensuring opportunities for the youth in a safe environment. The Jury also advises the UCLG Committee on Culture to support this process.

BAIE-SAINT-PAUL

The Jury appreciates the commitment and work developed by Baie-Saint-Paul with the project “City of Art and Heritage” that has sought to integrate culture into sustainable community development. In 2006 Baie-Saint-Paul was the first city in Québec to adopt a local Agenda 21 for culture; today, within its third action plan, the 2017-2022 Agenda 21 programme has supported an impressive cultural offer which relies on long-term projects, infrastructures and a strong public art policy that has led to international acknowledgement. The Jury advises the UCLG Committee on Culture to support this process.

BHOPAL

The Jury highlights the aim of Bhopal and the INTACH chapter to secure a strong cultural policy with the programme “Bhopal: Creating a Culture Policy”, in order to protect and promote cultural heritage in the city as one of the first initiatives in India to adopt the Agenda 21 for culture. It is remarkable the commitment of INTACH to act as the nodal agency for the local implementation of the commitments outlined in Agenda 21 for culture ensuring the dialogue and agreement of local government bodies and relevant stakeholders to carry projects based on the city’s own vision in the fields of environment, heritage, education, creative economies or participation. The Jury advises the UCLG Committee on Culture to support this process.

BOGOR

With the aim to preserve the identity of Bogor in terms of environment, infrastructures, public space and lifestyle, as well as to distinguish Bogor from other similar cities, the local government implemented in 2012 the “Bogor, Heritage City” project to rearrange building planning in the city generating high quality standards based on sustainable heritage policies. The Jury wants to emphasize the environmental and inclusive dimension of the initiative and advises the UCLG Committee on Culture to support this process.

BOLOGNA

When the “Incredibol! Project” was launched in 2012, Bologna started an ambitious plan based on creative innovation which has evolved to a relevant framework for regional policies and the Smart Specialization Strategy 2014-2020 in Emilia-Romagna region, regarding cultural and creative industries. The Jury praises the aim of the project to help develop projects for professionals in their start-up phase and energize the local economy having in mind the cultural dimension of sustainability, and requests that the UCLG Committee on Culture promotes it as a good practice.

BUSAN

“The Kangkangee Arts Village (KAV) Project” started in 2015 as an “urban regeneration initiative to reinvigorate a declining village by means of culture”. Formulated to restore the



original spirit of Kangkangee Village, birthplace of the modern shipbuilding industry of Korea, by cultural means, the project has involved close cooperation among residents, artists and the local government, in a public-private governance system that puts art and local culture at the core of the city sustainability policies. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

CATBALOGAN

“Catbalogs’s Manaragat Festival”, set in 2007, is “more than just a celebration of life”. It is a project intended to merge cultural and religious traditions in order to preserve the coastal identity of the region, through a one-month festival and yearly activities directed towards every citizen and tourist that may want to join the celebrations. The Jury highlights the initiative to shape local culture, history and economy taking into account the environmental assets of Catbalogan, and requests that the UCLG Committee on Culture promotes it as a good practice.

CHEFCHAOUEN


The Jury is pleased to have the city of Chefchaouen as a candidate to the International Award UCLG – Mexico City – Culture 21 with the “Mediterranean Diet Project”. Chefchaouen has made great efforts to promote the intangible cultural heritage, namely culinary traditions, social eating habits and celebrations, since its recognition in 2010 as a UNESCO Creative City. The Jury believes this task and the direct and transversal impacts generated, such as the rural-urban linkage, the creation of capacities and access to education for vulnerable groups and the sustainable consumption of local products, need to be fostered. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

CHEONGJU

“Our city is our museum – Communicating the significance of traditional communities in the historic centre of Chiang Mai” is a project conceived by the Chiang Mai Centre Museums Network. Despite being in its early stages, the Jury appreciates the strong steps already made to support the long-established communities along the Mae Kha canal by preserving their heritage and improving the environment, quality of life and attractiveness through arts and culture. ESCH-SUR-ALZETTE



The Jury highlights the international and intercultural scope of this initiative, involving students from several French, German, Portuguese and Lebanese secondary schools, and the effort to foster their intellectual and emotional skills through poetry and theatre. HOLA



Music, dance, religion, theatre or language are expressions of citizen’s sense of self and community that this initiative seeks to promote, preserve and adapt to new realities, with a “conservative yet innovative” vision. The Jury evaluates very positively this policy and the fact it takes into account vulnerable collectives and fights threats such as undesirable climate circumstances, and requests that the UCLG Committee on Culture promotes it as a good practice.

IZMIR

The Jury would like to praise the uniqueness of the “Izmir Mediterranean Academy”, a model of governance for culture that emerged in 2012 to address a new vision of the city based in communication and cooperation between different actors and cultural institutions, regardless their sphere of influence. This autonomous branch of the local government has become a relevant and innovative paradigm for local governance in Turkey, demonstrating that rather than cultural activity planning there is an urgency to create hybrid forms of decision-making structures that enable long-term flexible policies. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

KASHAN

The “Complex for Production and Proliferation of Green Spaces” of the municipality of Kashan started in 2014 as an urgent measure to address the economic, social, and environmental damages caused by recurrent drought in the region. This remarkable project combines educational and scientific resources such as the establishment of School of Nature for Children, addressing all age groups, regardless their gender and cultural and economic background, for a collective contribution to the sustainable development of the city. The Jury advises the UCLG Committee on Culture to support this process.

KAUNAS

The Jury highlights the commitment of Kaunas to revitalize and promote the modernist architecture that the city treasures; a magnificent testimony of the modernism ideas which shaped the identity of Lithuania in a unique artistic form during the interwar period. “Kaunas modernist community movement” is a project that clearly explains how the modernist community has become a relevant cultural actor since the city held the Kaunas Architecture Festival in 2013 and was awarded the European Heritage label in 2015, and also shows the city’s strategy for future cultural challenges to come: “Kaunas 2022 team understands that the past behind us can push us forward.” The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

KAZAN

“Parks and public gardens of Kazan City” has the goal to create new public green spaces and to beautify the existing ones with the active engagement of local residents and communities through a participative process. The project represents a clear movement towards the improvement of the quality of life through the creation of comfortable and safe conditions for cultural recreation and shows that parks and gardens are relevant spaces for cultural programming in the city and for learning about its cultural heritage. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

KISANGANI

The Jury would like to emphasize the effort made by Kisangani to provide the city with a theatre in order to reinforce the presence of culture among its citizens. The project “Acquiring, renovating and equipping cultural spaces” demonstrates that adequate equipment is crucial to ensure access to arts and culture and to promote the professionalization of local artists. The Jury praises as well the possibility of raising awareness about environment through a participative performing arts programme designed to better implement the Agenda 21 for culture. LAC-MÉGANTIC


The Jury praises Lac-Mégantic for presenting the project “Rebuilding Lac-Mégantic”, a testimony on how a city decides to transform itself after a railway tragedy, putting culture at the core of hard but strengthening works of reconstruction. The restoration works have been progressing ever since. The magnificent implementation of this project has resulted in the consolidation of not only an essential cultural infrastructure in Larissa but an integrated cultural policy that contributes greatly to social and economic development. LES ARTS ET LA VILLE (PRESENTED BY VAUDREUIL DORION)

“The Culture Action Strategy for Les Arts et La Ville Network” demonstrates how it is possible

Since 2015 four courses and thematic activities have been offered, along with "Culture Clinics" (support workshops) which bring about many participants from different sectors including education, culture, health, economy and many others. The Jury emphasizes the task undertaken by the network of ambassadors created specifically to disseminate and implement the project locally. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

LONGUEUIL

The Jury recognizes the exemplarity of the "Ten years of cultural mediation in Longueuil", a programme that is committed to the transformation of the city through cultural mediation, addressing issues such as poverty and access to culture and participation. The project explains the establishment of a framework for cultural mediation by the local government and the progressive provision of tools, means and services to artists and professional cultural organisations to meet the needs of disadvantaged population. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

LOUISVILLE

The Jury praises the great determination of the city of Louisville in working on one of the key challenges of sustainable cities: making the introduction of more efficient public services on health and more equitable policymaking, along with the activation of the community's arts and culture assets, to explore the nature of local wellbeing challenges with a humanities-based approach. The project "HEAL. The Artist as a catalyst for change", developed by IDEAS xLab & YouthBuild Louisville, reunites efforts through research, entrepreneurship, social activism and volunteering, among others, to better impact in the fields of Health, Equity, Art and Learning. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

LOURES

The project presented by the city of Loures called "Quinta do Mocho Public Art Gallery" demonstrates how art and its different forms of manifestation may be a powerful engine to boost integration and social inclusion for the entire city. In 2014-2015 Quinta do Mocho GAP evolved from an initial festival's activity to become a project itself focused on urban art, urban requalification and social inclusion, and today it is part of a wider strategy undertaken by the municipal government based on theatre, dance, music and sculpture as well. The Jury praises the multiple dimension of this initiative, having impacts at a human, economic and cultural level. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

LUTSK

The Jury praises the commitment of Lutsk to provide the city with an ambitious and integral culture policy that contributes to consolidating the role of culture as the main driver of sustainable urban development. The program “New generation of culture / Adaptation of Lutsk cultural policy to the requirements of the present” faces many challenges in the field of culture, such as preservation of cultural heritage, modernization of institutions, education and cooperation, based on the recognition and exhaustive analysis of the weaknesses of the current policies, aimed to address the lack of a cultural strategy in the Lutsk city development plan for 2030. The Jury urges the UCLG Committee on Culture to support this process.

MANNHEIM



NEVŞEHİR



PANAMA

The project submitted by Panama, “Culture Points: Community spaces for governance of culture, territorial sustainability and social innovation”, constitutes a perfect example of learning between cities, because it draws on a successful project set up in Brazil. It is about providing collective platforms in public schools for children, youth, adults and seniors, so they can engage in cultural activities in an accessible and intergenerational space. This project proves that, for Pavlograd, “culture has become not only a key pillar for sustainable development”, but a crucial component of life. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

PAYSANDÚ

The Jury highlights the determination of Paysandú to guarantee cultural rights for every citizen through the recognition of cultural diversity as a decisive factor in social and economic development. “Paysandú is culture: We’re all here” sums up the philosophy of this community, namely joining collective efforts in an exercise of multi-level governance to place culture as a pillar of sustainable development. The Jury positively evaluates all the programmes and activities implemented since 2015 and requests that the UCLG Committee on Culture promotes it as a good practice.

PÉCS

The municipality of Pécs committed to organise annual learning festivals for a three-year period as a result of winning the UNESCO Global Learning City Award in 2017. The programme “Learning City and Culture Working Together - Learning festival developments in the city of Pécs” describes the actions undertaken to accomplish this goal, focusing on attaining more local citizens to become active learners by engaging with the activities offered in the frame of the Learning Festival. The Jury praises the aim to improve active citizenship, inclusion of socially underrepresented groups and recognition of cultural heritage and values and requests the UCLG Committee on Culture to raise local awareness on the toolkit “Culture 21 Actions”.

PINCOURT


The Jury highlights the determination of Pincourt to improve citizens’ quality of life with the transversal programme “Culture as a driver of social development: Social Development Policy (PDS) in the town of Pincourt”, through the organisation of a large number of cultural activities within the framework of the Social Development Policy set in 2013. Despite of lacking a cultural policy, Pincourt is excelling for placing culture as a driver of sustainable development, fostering social cohesion, generating sense of belonging and involving residents in decision making processes. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

PUERTO DE LA CRUZ

The project “Puerto de la Cruz: a cultural environment” sums up the noteworthy trajectory of a city that has made culture a basic component of its sustainable development. The process of transformation of this community, whose principal asset is tourism, began in the early 2000s, but the creation of a strategic document in 2014 was the turning point to implement effective participatory mechanisms to guarantee the engagement of citizens and stakeholders in redefining the collective identity through culture. The Jury emphasizes the success of Puerto de la Cruz in adapting policies to new realities and valorising its cultural and natural richness, and requests that the UCLG Committee on Culture promotes it as a good practice.

RAMALLAH

The Jury recognizes de strong commitment of Ramallah Municipality as the first city in Palestine to present a 30-year development plan focused on cultural development. “A City for all” was launched in 2014 to adapt local policies to new realities, relying on the modern roles of local governments and considering specific necessities derived from the occupation of the territory for 70 years. It is noticeable the ambitious programme designed, including concerns on gender, cultural exchange and internal migrations. The Jury requests the UCLG Committee on Culture to support this process.

RENNES

The project “Expanding the Orchestra Class Programme in the priority neighbourhood of Le Blosne” consists in an extension of an educational programme on orchestral music, launched in 2009 with the aim to build the musical identity of Le Blosne, a stigmatized yet promising district in Rennes. The Jury praises the willingness to provide arts education by offering this opportunity to citizens living in areas in need, and positively evaluates the future establishment of a Conservatory by 2020, which will help disseminating the work done with this programme. The Jury requests the UCLG Committee on Culture to support this process.

ROBERVAL

The project “Museum showcases” started in 2015 as a remarkable initiative led by a committee made up of members of the Chamber of Commerce of Roberval, artists, citizens, and merchants to overcome a process of devitalisation of the city. With the main goal to use the vacant storefronts to display inspirational initiatives and reinforce the town centre image, this project positively exemplifies the success of a strategy based on good governance and cultural mediation to bring back pride and enthusiasm to the city. The Jury requests the UCLG Committee on Culture to support this process.

ROSARIO

“Municipal School of Clothing Design - Creative processes of collective textile production and distribution” shows the growth of a worthy initiative created in the framework of local government’s policy of inclusion and youth empowerment development. A wide range of workshops focused not only in education but also in production are offered in different districts of the city; they provide comprehensive training on the full creative process of clothes design with critical and gender approaches and a decentralizing nature. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

ROSTOV-ON-DON

The “East -West European Jazz Orchestra” (EWEJO) was created under the leadership of two twin-cities: Rostov-on-Don and Dortmund, with the aim to globally connect jazz musicians and music enthusiasts from all over the world. This project constitutes a magnificent cultural exchange, providing young talented musicians the opportunity to develop their abilities on the stages of the biggest international jazz festivals. The Jury requests the UCLG Committee on Culture to support this process.

SAINT-CAMILLE

The Jury praises the programme “Culture and citizen involvement as a strategy for territorial revitalisation in the rural municipality of Saint-Camille” as an outstanding initiative that describes how a small community embraced culture to revive. Thanks to leadership of Le



Petit Bonheur cultural and community centre and the joint mobilisation of the administration, private sector, cooperatives, volunteers and academy, this “World village”, as Le Monde affirms, has managed to achieve unequalled success. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

SAN JOSÉ

The Jury recognizes the exemplarity of the “2013-2021 Action Plan for Cultural Policy in San José (PCSJ)”. This programme has counted on massive participation and has to do with the collective development of San José through the implementation of cultural rights, diversity, equity, coexistence, creativity and innovation. The Jury commends the efforts made in order to place culture as a pillar of sustainability at the core of public policies in the city, strengthening cross-cutting strategies designed to involve all sectors. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

SANCAKTEPE


“Happy Homes” in Sancaktepe encourages women to take part in public life participating in training events specifically designed to strengthen the family values, considered as the cornerstone of society. The project aims to create both social and individual awareness on “new lifestyles” which can put at risk the basic traditional values of the family institution. Since 2012 a growing number of women and also children have benefitted from workshops on handicrafts, kitchen arts, language or music and performing arts. The Jury requests the UCLG Committee on Culture to raise local awareness on the toolkit “Culture 21 Actions”.

SANTA FE

As a thriving city that encourages innovation and transformation, Santa Fe aims to position itself as an international design centre and a promoter of cultural policies through the programme “Santa Fe as a design hub”. Since 2008 more than 1000 local and regional entrepreneurs linked to design have benefitted from this initiative, 30 major design fairs have been held and many business and design clusters have been created. The Jury considers worth mentioning the impressing impact on gender equality: women are the protagonists in this sector leading 90% of the entrepreneurship, thus making possible the development of policies with a gender approach. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

SANTA MARIA DA FEIRA

“Imaginarius – International Festival of Street Theatre” was originally a festival that began in 2001 in Santa Maria da Feira, the Capital of Culture of Atlantic Axis 2018. The Jury praises this project as an example of an initiative that has transcended its original framework to become a magnificent comprehensive cultural project: not only promotes, annually, the biggest Street

Arts' event of the Iberian Peninsula, but also fosters decentralized creation and production of performative street arts all year around, including active participation of children and youths, through the "Imaginarius - Creation Centre". The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

SANTIAGO

"My Santiago" constitutes a historic achievement for a cultural programme promoted by a regional government in Chile representing an unprecedented landmark in terms of public investment in culture. It is an excellent project oriented to the development of cultural policies based on associative logic to address inequalities of access. The Jury highlights the work with 52 municipalities for a cohesive, equitable and quality cultural offer in the Metropolitan Region, through the creation of a network of public cultural centres. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

SANTO ANDRÉ

"Encouraging artistic creation" summarizes the ascending trajectory and consolidation of an initiative which started in 1990 as a programme of incentives for artistic creation in Santo André. Public schools of cinema, theatre, dance, and other cultural facilities were created, and decentralised workshops were also promoted in community centres of different neighbourhoods. The Jury praises the capacity to address management weaknesses related to the complexity of this programme, which has needed a reformulation over time in order to rebuild a successful coordinated policy on artistic creation. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

SEFERİHİSAR

Seferihisar Children Municipality (SCM) has the appraisable goal to educate children on democracy, providing them with a transparent, democratic and participatory mechanism to engage in the logic of municipal decision-making processes. The Jury positively evaluates the priority given to children investing in them in assurance of a better future and liveable world. To date, 650 students between the ages 6-18 have registered at the Children Municipality, taking part in the planning of the municipality's cultural events and learning about the municipal policies' functioning with a gendered and inclusive approach. The Jury requests the UCLG Committee on Culture to support this process.

SEGOU

"Ségou: a creative city" is a strong cultural policy created to harmonise and cohere all the strategies carried out in Ségou regarding the regional planning model, in order to take into account new priorities and the potential of local cultural development and sustainability. It is based on four key areas, namely music, fashion and design, visuals arts and capacity building,



and focuses its efforts on cultural actors, city officials, civil society, artists, and local population, including disadvantaged groups. The Jury highlights the commitment of Ségou to intensely promote culture as a pillar of sustainability through creativity. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

SEMARANG

The Jury praises the city of Semarang for its commitment to fight against poverty in a joint effort with the citizens and cultural actors through innovation and culture. The project “Thematic Kampung, ‘gotong-royong’ culture as the backbone of sustainable development” is an excellent initiative that demonstrates how a local government can provide the adequate tools for the citizens to become active subjects in the transformation of their communities. The Jury celebrates the “working together” philosophy of ‘Gotong-royong’ applied in the creation of each thematic Kampung to display the cultural identity of communities, and requests that the UCLG Committee on Culture promotes it as a good practice.

SFAX


The “Culture Without Walls, Cultural Pluralism” programme started in 2013 with the aim to provide the citizenry with a cultural public infrastructure based on decentralization, inclusivity and democracy. This constitutes a noteworthy process which goes beyond the usual expectations, since Sfax needed a whole new cultural policy to be formulated after big political changes in 2011. Among many other achievements, the Jury praises the creation of cultural centres in non-cultural institutions such as the civil prison and rural or marginal areas, as a result of the decision to improve cultural facilities in public spaces. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

SURAKARTA

“Revitalization of Sriwedari Cultural Park” is an urban regeneration programme which started in 2015 with the goal to build understanding among communities by accommodating culture activities in public spaces. With the reformulation of Sriwedari Heritage Site through cultural empowerment, the city has improved its attractiveness to stimulate tourism and creative economy, bringing benefits to all the citizens and fostering the Javanese identity at a national and international scale. The Jury highlights the city’s determination to become a cultural city taking into account sustainability challenges. The Jury requests the UCLG Committee on Culture to raise local awareness on the toolkit “Culture 21 Actions”.

SORIA

The Jury highlights the broad scope of the programme “Numancia 2017-2019”, including scientific, educational and touristic goals based on a unique history of freedom and resistance dating back to the Roman Empire. The Jury positively evaluates the involvement of many

The Jury requests the UCLG Committee on Culture to support this process.

STRASBOURG

“On Your Marks, Get Ready... Sing!” is a “citizen musical project” with a social vocation to promote inclusive, free and committed citizen participation in the long term. Built in a 3-year cycle, it entails performing masterpieces of the classical repertoire in a participatory concert, having rehearsed previously in various workshops with renowned masters and musicians. The Jury praises the commendable will to bring classical music closer to all citizens, bolstering at the same time the decentralization of culture and more democratic and people-centred policies, and requests that the UCLG Committee on Culture promotes this project as a good practice.

TAICHUNG

“Turning over the old downtown area, redeveloping Taichung into a city of culture - The Natural Way Six Arts Centre (former Martial Arts Compound of Taichung Criminal Law Enforcement Office)” describes the reconversion of a historic building in a successful art centre through a public policy of expanding urban regeneration. This initiative perfectly illustrates how a policy based on urban planning, heritage and education can lead to the whole cultural transformation of a city and inspire similar initiatives at a regional level, related to the commitment to preserve historical fields and cultural assets with the aim to enhance quality of living of citizens. The Jury requests the UCLG Committee on Culture to support this process.

TAIPEI

“Transforming Taipei’s Cityscape: Public-Private Partnership in Cultural Praxis” comprehends two projects: The Old Building Cultural Movement, focused on the transformation of old and abandoned buildings into cultural spaces for public use, and Inclusive Playgrounds, which brings together artists, designers, and play equipment manufacturers to build inclusive playgrounds based on the specificities of each community. The Jury praises the advances made towards good governance with these two initiatives based on heritage and creativity, demonstrating the efficiency of the collaboration of private and public sector and the citizenry when an integrated vision of policies prevails. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

TALCA

“School work”, spreading Mapuche knowledge in school and community environments” shows the importance to keep strengthening the work initiated by professionals from the Indigenous Association Inche Tañi Mapu, in partnership with the Municipal Corporation of Culture, to



recognize and transmit the rights, identity, language and traditions of the indigenous peoples living in the commune of Talca. The Jury praises the favourable culture and educative framework provided by public policies in Talca for the proper development of the project and the effort of all the actors involved, including schools, families, children and youth, working for intercultural education on equality and inclusiveness. The Jury requests that the UCLG Committee on Culture promotes it as a good practice.

TEHRAN

“Tehran Book Garden” (TBG), “the symbol of Iran’s modern literature”, constitutes a perfect example to illustrate the importance given to the transmission of art and scientific knowledge in the framework of local cultural policies. TBG is a modern complex for entertainment aimed at increasing the number of readers in childhood and adolescence. It includes bookstores, art shops, science shops, and some modern science centres, but it also constitutes an emerging hub for publishing professionals. The Jury requests the UCLG Committee on Culture to support this process.

TEL AVIV-YAFO


DigiTel responds to the Smart City strategy developed by Tel Aviv-Yafo in recent years. It is a public digital platform which provides citizens with personalised information on cultural life in the city and other useful services. This project collects data based on user’s behaviour and location to develop policies focalised to meet the needs of the residents in a more customer-centred approach, and it constitutes a relevant initiative on technology investment to foster access to culture and a better coexistence in cities. The Jury requests the UCLG Committee on Culture to support this process.

TERRASSA

The Jury recognizes the exemplarity of “Terrassa - City of Film”, a local cultural strategy aimed to bolster innovation, talent, and creativity as pillars for the future economic and cultural development of the city. Terrassa has invested all its efforts in redefining itself in the creative sector through cinema with the wish to “make the city a worldwide benchmark in this field”, building on industrial production, infrastructures and historic heritage as the main assets of the city. The Jury highlights the coherence and pertinence of this solid initiative that puts into value the legacy of a successful collective creative past, and requests that the UCLG Committee on Culture promotes it as a good practice.

TROIS-RIVIÈRES

The Jury would like to emphasize the exemplary trajectory of Trois-Rivières, once known as the “paper capital of the world”, which rebounded from a serious economic crisis in the 1990s to become the “Cultural Capital of Canada” in 2009. After adopting and renewing its cultural policy in order to position culture as a driver for the city’s sustainable development, and thanks to the

VILLA MARÍA




